# New Features, Improved Performance

The latest release of Cim50, version 2021.2 has arrived.

This version is our first release since v2020 where we have included a range of exciting new features.

Along with a refreshed user interface, we have incorporated new functionality through-out the whole system, as well as including some significant performance improvements in the Stock Control module.

We are excited to bring this release to you, for more information on all the new features and issues fixed please read below.

# Stock Control - New Features

### Performance Improvements

We have worked hard with this release to improve the performance of screen loading and processing times in the Stock Control.

You should notice a significant improvement when opening records, interrogating the stock profile, or processing dispatches and receipts.

We will be monitoring user feedback on the performance improvements and will look to roll out similar performance improvements in the other modules.

#### Traceable Stock Improvements

You can now add traceable analysis and additional info fields into the traceable entry and enquiry screens, allowing for more efficient input and retrieval of key data related to traceable records.

#### Carbon Emissions Capture

You can now configure your system to calculate the Carbon Emissions associated with manufacturing your products.

There are 2 modes available to calculate your Carbon Emissions. Depending on the information you have available, you can have the system estimate your emissions based on your energy/fuel bills, or you can specify exact fuel usage values to provide an accurate emissions figure.

Once configured, the system will provide you with a Carbon Emissions figure in KgCO2e (Kilograms of Carbon Dioxide equivalent). You can interrogate you total emissions over a period, and offset your emissions online should you wish to offer a carbon neutral manufacturing process.

The 'Barcode' field located in the Sage 50/Cim50 Stock Record is now recognized by the SFDC system when scanning items through the system.

This will allow you to configure items you will receive with your suppliers barcode and when scanning those barcodes through SFDC the system will identify it and process it for the relevant item within your system.
